

1. Caution and Safety Instructions

- Keep all O-rings and sealing surfaces clean during installation and servicing; failure to do this may lead to premature failure of the product.
















2. Product Information

Suitable for mounting within 1.2 meter (4 feet) off the ground.




Tools Needed:



4. Repair/Replacement Instructions


• Standard Optics (20°, 40°, and 60°)




1. Use a $\%_4$ " Allen key to unfasten the 8-32 x $\%_6$ " (11 mm) screw, using a $\%_4$ " Allen key. Lift the cap outward to remove, Avoid using metal tools to protect the powder coat finish.



2. Lift the cartridge arm and turn it counterclockwise to release the lock. Pull the complete cartridge out of the fixture housing.




3. Rotate the cartridge arm back into the neutral position. Twist the optic counterclockwise and pull outward to remove the optic.




4. Use a #2 Phillips screwdriver to unfasten one screw inside the cartridge.







5. Twist and agitate the upper cartridge component to remove the top portion.



6. Use a Phillips #1 screwdriver to unfasten the three LED module screws. Remove the reflector adapter ring and LED module from cartridge platform.




7. Remove the driver clamp using a #2 Phillips screwdriver.




8. Push the black, six-pin connector downward to unlock it from the cartridge.






9. Remove the driver from the cartridge.

Very Wide and Wall Wash Options




1. Disassemble the fixture using steps 1 and 2 in previous section.




2. Use a #2 Phillips screwdriver to unfasten one screw inside the cartridge.







3. Twist and agitate the upper cartridge component to remove the top portion.



4. To remove the reflector from the LED module, carefully insert a precision-slotted screwdriver between the module and the reflector and lift outward. Repeat in a circular manner around the base of the reflector until it is disconnected.




5. Use a #1 Phillips screwdriver to unfasten the three LED screws. Remove the reflector adapter ring and LED module from the cartridge platform.




6. Use a #2 Phillips screwdriver to remove the driver clamp.
